Registration and Payment Policies

DEPOSIT INFORMATION – Registration for each camper must be accompanied by non-refundable payment of \$285. This includes a \$35 registration fee plus a \$250 deposit, which is credited towards the camp balance. An Arrangement for Payment form must be completed, signed and returned along with the registration form and deposits.

DISCOUNTS –

1. **Early Bird Discount:** Registration fees will be waived for all families registering by **February 1, 2009.**
2. **Sibling Discount:** Camp fees for your first child will be paid at the appropriate camp fee. Each additional child will receive a sibling discount of \$25. **The discount is taken off the final camp balance only.**

CANCELLATIONS, REFUNDS, & CHANGES – In accepting an enrollment, the camp reserves a space for your child(ren). If, for ANY reason, the enrollment must be cancelled, the camp must be notified of the reason **IN WRITING IMMEDIATELY.** The \$35 registration fee and \$250 deposit are **nonrefundable.** A full camp fee refund, less registration deposit and registration fee, is available until **April 1, 2010,** There will be **NO** refunds or credits after **May 1, 2010.**

PAYMENTS – All Levis JCC camp fees must be paid in full before **May 1, 2010.** All registrations after **May 1, 2010** must be paid in full at the time of registration.

FINANCIAL ASSISTANCE –

1. Financial assistance applications are available starting **NOVEMBER 16, 2009** from the Levis JCC Financial or Camp offices which are located in the Sports and Wellness Center Friedberg Administrative Offices.
 - a. Anyone wishing to apply for financial assistance must submit an application by **February 26, 2010** to the Adolph & Rose Levis Jewish Community Center.
 - b. Financial Aid is based on 2010 fees.
 - c. Financial Aid fee of \$30 will be required along with \$285 deposit to process the financial aid request.
2. All inquiries and applications are kept in strictest confidence. Camp deposits and registration fees must be paid in full before applying for financial assistance. In the event that financial assistance award is insufficient, all deposits and registration fees will be refunded or credited to your account. In this situation, please submit a refund request in writing to the camp office immediately.
