## CONDITIONS OF ENROLLMENT

The undersigned acknowledges that he/she is the parent or guardian of the camper designated above and has full authority to enroll the child in a summer camp program. The undersigned further acknowledges that the information contained in this application is true and accurate.

Each applicant must provide the Adolph and Rose Levis JCC's Camp Kavod with a deposit in the amount of \$300 plus a \$50 registration fee at the time the original application is submitted for processing. It is understood that all money paid is fully refundable less the \$50 registration fee if cancellation is made prior to January 31, 2011 and refundable less \$350 if cancellation is made prior to March 31, 2012. Notification of cancellation must be in writing. Thereafter, no refunds will be given for any reason. The remaining balance will be divided into installments based on the date of registration, with the full balance being due by May 1, 2012. In the event that the tuition fee is not paid in full by the date the session is scheduled to begin, then all monies on account with Levis JCC Camp Kavod shall be forfeited as and for liquidated damages and the camper's reserved place in the session shall be forfeited. Should any legal action need to be taken, the undersigned will be responsible for any legal fees incurred.

No allowance or reduction in the tuition will be given for a camper's late arrival or early withdrawal. No assignment of this contract by either party shall be valid or binding on the other unless the assignment is in writing and approved by written consent of the other party.

In enrolling a child in the Adolph and Rose Levis JCC's Camp Kavod, the undersigned authorizes the officials of the Adolph and Rose Levis JCC to act for the parents while the child is in their care. This includes the power to authorize emergency treatment when it is deemed necessary and in the best interest of the child.

Participation in any of the Adolph and Rose Levis JCC activities and use of any recreational facilities involves risk of accidental injury despite all safety precautions. Having been informed of the activities to be conducted by the Adolph and Rose Levis JCC, the undersigned assumes all risks and hazards incidental to the activities and release from responsibility and agree to indemnify and hold harmless the Adolph and Rose Levis JCC, its officers, directors, independent contractors, volunteers and all employees for any illness or injury to the undersigned, his or her child or family members occurring during his/her/their participation in any activity or use of any facility at/or conducted by the Adolph and Rose Levis JCC.

This contract contains all of the terms and conditions agreed on by the parties and no other agreement, oral or otherwise, regarding to the subject matter of this contract, shall be deemed to exist or to bind any of the parties.
