CONDITIONS OF ENROLLMENT

The undersigned acknowledges that he/she is the parent or guardian of the camper designated above and has full authority to enroll the child in a summer camp program. The undersigned further acknowledges that the information contained in this application is true and accurate.

Each applicant must provide the Adolph and Rose Levis JCC with a deposit in the amount of \$300 plus a \$50 registration fee at the time the original application is submitted for processing. It is understood that all money paid is fully refundable less the \$50 registration fee if cancellation is made prior to January 31, 2012 and refundable less \$350 if cancellation is made prior to March 31, 2012. Notification of cancellation must be in writing. Thereafter, no refunds will be given for any reason. The remaining balance will be divided into installments based on the date of registration, with the full balance due by May 1, 2012. In the event that the tuition fee is not paid in full by the date the session is scheduled to begin, then all monies on account with Levis JCC shall be forfeited and the camper's reserved place in the session shall be forfeited. Should any legal action need to be taken, the undersigned will be responsible for any legal fees incurred.

It is understood that incentives and/or discounts may not be applied if additional Financial Aid is awarded for a child's tuition.

No allowance or reduction in the tuition will be given for a camper's absence. No assignment of this contract by either party shall be valid or binding on the other unless the assignment is in writing and approved by written consent of the other party.

In enrolling a child in the Adolph and Rose Levis JCC Summer Camp, the undersigned authorizes the officials of the Adolph and Rose Levis JCC to act for the parents while the child is in their care. This includes the power to authorize emergency treatment when it is deemed necessary and in the best interest of the child.

Participation in any of the Adolph and Rose Levis JCC activities and use of any recreational facilities involves risk of accidental injury despite all safety precautions. Having been informed of the activities to be conducted by the Adolph and Rose Levis JCC, the undersigned assumes all risks and hazards incidental to the activities and release from responsibility and agree to indemnify and hold harmless the Adolph and Rose Levis JCC, its officers, directors, independent contractors, volunteers and all employees for any illness or injury to the undersigned, his or her child or family members occurring during his/her/their participation in any activity or use of any facility at/or conducted by the Adolph and Rose Levis JCC.

Submission of completed medical forms is a mandatory state law, required for attendance. Failure to disclose any pre-existing medical conditions, including cognitive, social and/or motor disabilities, or failure to disclose a change in dosage of regularly prescribed medication may result in dismissal from camp without refund or proration of tuition.

This contract shall become binding when signed by an authorized agent of Adolph and Rose Levis JCC Summer Camp, without delivery of a copy thereof to the undersigned applicant. If Levis JCC is unable to perform any of its obligations under this contract by reason of fire, strike or damage by the elements, or of any unavoidable casualty, the obligations on its part will terminate at once. This contract contains all of the terms and conditions agreed on by the parties and no other agreement, oral or otherwise, regarding to the subject matter of this contract, shall be deemed to exist or to bind any of the parties.
